To the Reverend Clergy, Parish Councils and Faithful of the Diocese of New England,

The 51st New England Diocesan Assembly will convene on October 24-25, 2014, hosted by Dormition of the Virgin Mary Church, Cumberland, RI. Registration begins on Friday morning at 8:30 A.M. Clergy and Lay delegates are reminded that this is a two-day assembly, and all are expected to be present for the entire assembly.

Details regarding hotel accommodations, registration for the assembly - including delegate accreditation forms and travel details are included in this attachment. In the second attachment please find the draft minutes from the 51st Diocesan Assembly. Another email, early in September, will contain the proposed budget for 2015. All parishes are receiving this packet in electronic form only.

Please note that the deadline for the hotel is **September 30th**, the forms and banquet registration is **October 5th**. If you do not intend to be at the banquet please indicate so. We will be charged for all meals that are ordered.

As indicated in the Statute of the Orthodox Church in America, the parish lay representative(s) are to be chosen by election — either at a general parish meeting or a parish council meeting, according to local practice. The number of lay representatives corresponds to the number of assigned (not attached) clergy — priests and deacons — in the parish. Vacant parishes may elect and send one (1) lay representative. Accordingly, lay representation to the 51st assembly is on the enclosed sheet.

In order to send voting delegates to the Diocesan Assembly, parishes must be current with their Diocesan and OCA Fair Share that is at least through the fiscal year just ended on August 31, 2014. Please note that lay delegates whose parish fair share is not current will be seated as observers.

Vespers will also take place at the country club and will be followed there by the customary assembly banquet. On Saturday, a brunch and the assembly's closing plenary session will take place in the parish hall immediately after the Divine Liturgy at the Holy Dormition Church, on Fountain Street off Manville Hill Rd, in Cumberland. Night lodging accommodations are available for all delegates and guests at the Providence Marriot Downtown, One Orms Street, Providence, RI 02904 (401 272-2400, fax 401 273-2686) at the special group rate of \$149 per room. Reservations must be completed no later than September 30th, 2014, not only to assure securing the group rate but even to secure a room, since the dates of our assembly coincide with local college weekends. **Reservations can be made by telephoning the following toll-free number (866 807-2171) for the group, Orthodox Church in America, Diocese of New England.**

## **Directions to Holy Dormition Orthodox Church**

### ***From the south***

*Route 95 North to Route 146 North to Route 295 North to Exit 10  
Turn right at the end of the exit ramp onto Route 122 (Mendon Road)  
Continue on Route 122 for 2.7 miles to Manville Hill Road  
Turn Left on Manville Hill Road and continue down the hill for 3/10 mile.  
Turn left onto Fountain Street. A sign for the church is on the left corner.  
Go straight up the hill to the church.*

### ***From the north***

*Route 95 South to Route 295 South to Exit 10  
Turn right at the end of the exit ramp onto Route 122 (Mendon Road)  
Continue on Route 122 for 2.7 miles to Manville Hill Road  
Turn Left on Manville Hill Road and continue down the hill for 3/10 mile.  
Turn left onto Fountain Street. A sign for the church is on the left corner.  
Go straight up the hill to the church.*

## **Directions to the Kirkbrae Country Club**

The least complicated way is to go to Dormition Church in Cumberland, first, from whatever your point of origin may be and to proceed to Kirkbrae from the church according to the following instructions. The drive is 10 to 15 minutes.

Turn left from Fountain Street onto Manville Hill Road  
Proceed down-hill and across the bridge over the Blackstone River  
Pass through the intersection and proceed on Main Street to Old River Road  
Turn left onto Old River Road for almost 2 miles  
The Kirkbrae Country Club is on your left and the parking lot is on your right

## **From Kirkbrea Country Club to the Marriot**

Exit the Kirkbrea Parking Lot turning right onto Old River Road

Proceed on Old River Road about 1/2 mile to Route 116 North

At traffic light (just after Lincoln High School on your left) ~ turn right onto 116 North

After three traffic lights turn right entering onto 146 South - Providence

Proceed on 146 South for almost nine miles and exit at the Admiral Street Exit

Turn left onto Admiral Street crossing a bridge

At traffic light turn right onto Branch Avenue

Proceed on Branch Avenue as it curves right ~ passing a liquor store and gas station on your left

At the traffic light turn right onto Main Street (the Marriot is visible on your right)

Turn right onto Orms Street and enter the Marriot Parking Lot

## **From Marriot Providence Downtown to Dormition Church**

Exit Marriot Parking Lot turning left onto Orms Street

Turn Left onto Charles Street and proceed to Admiral Street Intersection

Proceed through the intersection and move into the left lane

Turn left onto the entrance for 146 North

Proceed northbound on 146 North to 295 North

Enter 295 North and exit onto Exit 10 (Cumberland)

Turn right onto Route 122 (Mendon Road)

Proceed on Route 122 for almost 2 miles to Manville Hill Road ~ (Poppy's Restaurant on left)

Turn left onto Manville Hill Road and proceed down-hill ~ to sign for Dormition Church

Turn left at the black/white sign for the church on your left ~ and proceed up-hill to the church
